# GENERAL TERMS AND CONDITIONS

## Our quotation

Our quotes are valid 5 days after you have received our tentative quote. After receipt of your final information on itinerary and revisions, rate changes might apply.

A complete detailed itinerary is required 10 days prior to the date of service.

## Prices subject to change

All prices quoted are subject to change if the price of diesel fuel increases by more than twenty percent (20%) between the date of quote and the day of the trip.

## Deposit

A thirty percent (30%) non-refundable deposit is required to reserve and confirm service (s).

## Payment

All services must be pre-paid.

Balance of payment is due and payable ten days prior to the date of service to guarantee reservation and quote. Please arrange with us your method of payment. Payments may be made by check, credit card or wire transfer. Services are subject to cancellation if payments are not received as per set terms.

A charge of 1.5% per month (totaling 18% per year) will be billed for all past due accounts. Travel By Bus!, LLC. shall be entitled to costs of collection and attorney fees in the event of a default by the customer.

## Cancellation

There is no cancellation fee if the cancellation is made in writing (fax or e-mail) at least thirty-one (31) days prior to the date of service. Later cancellations are charged as a percentage of the total costs of the contracted service:

15 to 30 days prior to date of service	30% cancellation fee
14 to 8 days prior to date of service	50% cancellation fee
7 to 0 days prior to date of service	100% cancellation fee

A change in date of motor coach service is a cancellation.
